# A Message **From Our CEO**

### **Dear Friends** and Supporters,

At Riverwood Healthcare, delivering the highest quality patient-centered care is a top priority in all that we do. And we are continually examining emerging healthcare needs of the communities we serve throughout Aitkin County and the Garrison and Lake Mille Lacs area.

One of those needs is an increasing elderly population in need of dialysis services closer to home. After a thorough analysis of kidney care needs and services currently available, Riverwood and CentraCare Health signed a letter of intent to collaborate on a new dialysis facility to serve residents of Aitkin County and the surrounding area. Subsequently, our Governing Board and senior management did an extensive review of options for the location of a dialysis unit as well as evaluating other clinical needs on our Aitkin campus.

For specialty care, we will redesign and enlarge our clinic to accommodate expanded imaging capabilities for orthopaedic care. For primary care, we will re-organize clinic space to support a team-based model of care. For kidney care, we will partner with CentraCare to operate a kidney dialysis unit to be located in renovated space currently occupied by the rehabilitation department. A new rehabilitation department will be constructed near the front of the building adjacent to the specialty clinic. Groundbreaking for this project is set for Summer 2017.

After careful deliberation, we have decided to proceed with a clinic expansion and renovation project that addresses specialty care needs, outpatient primary care as well as kidney care.



**OUR MISSION:** To improve health by providing high quality, compassionate and personalized care.

Another growing health concern for the community we serve is heartburn and acid reflux. Collaborating with Cuyuna Regional Medical Center on the launch of the Minnesota Reflux and Heartburn Center (MRHC) in 2016, we saw significant growth in the number of people receiving advanced care for gastroesophageal disease. From fiscal year 2015 through 2016, Riverwood saw an astounding increase in Barrett's esophagus/esophageal cancer screenings, including a 77% increase in EGDs, an 82% increase in lower gastrointestinal fundoplications, and a 391% increase in Bravo monitoring of GERD symptoms. To support these growing patient volumes, we added a MRHC nurse coordinator in Aitkin, Dawn Harcey, to help patients navigate customized plans of care.

With our aging populations, orthopaedic care continues to see a lot of growth. Together with Cuyuna Regional Medical Center, we added two orthopaedic surgeons, Dr. Jonathan Herseth and Dr. Susan Moen. Dr. Herseth brings sports medicine training as well as general orthopaedic surgery skills for joint replacements and other care. Dr. Moen is the only area orthopaedic surgeon specializing in diagnosing and treating hand, wrist and elbow conditions. The Rapid Recovery pain management protocol, rolled out in 2014 by Dr. Erik Severson, continues to support excellent patient outcomes for those with hip and knee replacements.

In 2016, we added providers in primary care areas as well. We were pleased to welcome two new family physicians, Dr. Erik Bostrom and Dr. Melissa Herbranson, and another family nurse practitioner, Karen Bartron-Sundeen. In addition, we added a third internal medicine provider, Faith Nyberg, physician assistant, who oversees hospital patient care and maintains an outpatient practice. At year-end, Faith Peterson, family nurse practitioner dedicated primarily to urgent care, joined our growing provider team.

On behalf of the Governing Board, I want to thank all Riverwood employees, healthcare practitioners, donors and volunteers for all they do to support outstanding patient-centered care.

# Quality and Patient Safety

At Riverwood Healthcare, our mission is to improve health by providing high quality compassionate and personalized



care. From clinic exams through emergency care and hospital stays, high quality personalized care is a promise we deliver on every day.

Our organization demonstrates a strong commitment to continuous quality improvement that shows in our patient satisfaction ratings. Since 2014, Riverwood has partnered with Press Ganey to measure inpatient, clinic, ambulatory surgery, emergency care, urgent care, and rehabilitation patient satisfaction. These survey results guide patient care delivery improvements and offer positive feedback for the excellent work our healthcare professionals are doing.

For the third consecutive year, Riverwood Healthcare Center was one of the hospitals nationwide given a five-star rating based on patient satisfaction from the Centers for Medicare and Medicaid.

Riverwood has also received four-star rating overall in patient satisfaction data, quality data, and cost data from the Centers for Medicare and Medicaid.

In support of Riverwood's commitment to high quality, convenient, and personalized patient care we implemented Excellian on April 1, 2016. Excellian is an electronic health record platform of EPIC, one of the most advanced and widely used electronic medical records. With consent, the software allows a patient to have a single medical record across all organizations using Excellian, allowing healthcare providers to have the most up-to-date medical history for patients. At Riverwood, our entire team of healthcare professionals contributes to the delivery of high quality care for our patients in a safe environment.







# Foundation Donors Support Quality Healthcare in Rural Minnesota

In 2016, Riverwood Foundation donors helped respond to various healthcare needs in the communities we serve.



More than \$30,000 was raised to support local hospice care from participants and sponsors for our annual July golf event. Through our annual fall Gala, more than \$45,000 was generated for new hospital bed mattresses at Riverwood.

Through the endowment scholarship funds, two local nurses and one medical student received support for advanced education. The Roger D. Wilson Scholarship Fund awarded \$2,000, and the Michael Zilverberg Scholarship Fund made two awards for \$2,500 each. In addition, seven children with cancer received grants from the Zachary Johnson Kids with Cancer Fund.

Riverwood Foundation donors recognize the importance of supporting advanced medicine to be delivered locally so that patients don't have to travel out of the area.

We appreciate every gift that helps our local hospital respond to the evolving healthcare needs of the communities we serve.




## Donor Dollars at Work
