

Fiscal Year 2019 Foundation Report

During the 2019 fiscal year, we reached a major milestone with the completion of our Growing Together Capital Campaign. Thanks to the generosity of many individuals and organizations, we raised more than \$1.2 million for the renovation and expansion of Riverwood's Aitkin Clinic. This project included the addition of a kidney dialysis center, which CentraCare Health began operating in January 2020.

For our annual Gala in September, we chose a new venue at the Aitkin County Fairgrounds with a fun "Derby" horse racing theme. This event raised more than \$36,000 for the expansion of mental health services at Riverwood.



In July, Riverwood Foundation hosted the annual Golf Charity Event at Cuyuna Rolling Hills in Deerwood with all proceeds designated for the new kidney dialysis center.

Thank you to all who have invested in the future of healthcare services for Aitkin County and surrounding communities in the McGregor and Garrison/Lake Mille Lacs area.

Riverwood Foundation disbursed \$320,780 to Riverwood Healthcare Center in fiscal year 2019 (see pie chart).


